A bill to allow States to require payment of State fees related to boating as a condition for issuance of a vessel number and to collect such fees in conjunction with other fees related to vessel numbering.

Recently, the Coast Guard has blocked a number of states from collecting these fees, which help fund programs to address aquatic invasive species, boating safety, search and rescue and others. **Recovering Americas Wildlife Act (RAWA)**

Funds conservation efforts for more than 12,000 species of wildlife and plants in need of assistance by providing \$1.4 billion in dedicated annual funding

Includes: (d) Wildlife Management Responsibilities.—(E) To manage, control, and prevent invasive species as well as diseases and other risks to wildlife.

**19 bipartisan co-sponsors** 

Status: Committee on Environment and Public Works.

## H.R. 7408 (Rep. Westerman (R- AR)), "America's Wildlife Habitat Conservation Act."

**RAWA** "light"

Authorize lower levels than the Senate version — approximately \$200 million to \$500 million per year.

funding depends on annual congressional appropriations and would end after five years.

Makes controversial changes to Endangered Species Act

22 co-sponsors all Republicans

**Status:** Out of committee (4/16/24) ...unlikely house passage ..is RAWA dead this congress???....very unfortunate

Still to be resolved in all RAWA Bills over the last three congresses – how to fund it

**S.873 America's Outdoor Recreation Act of 2023** (3/20/23) Sens Manchin (D-WV) and Barrasso (WY), reintroduced

(b) AUTHORITY OF BUREAU OF LAND MANAGEMENT, BUREAU OF RECLAMATION, NATIONAL PARK SERVICE, AND FOREST SERVICE WITH RESPECT TO CERTAIN AQUATIC RESOURCE ACTIVITIES ON FEDERAL LAND AND WATER.

- IN GENERAL.—The Secretaries may inspect and decontaminate vessels entering or leaving Federal land and water located within a river basin that contains a Bureau of Reclamation water project.
- 2) (c) GRANT PROGRAM FOR RECLAMATION STATES FOR VESSEL INSPECTION AND DECONTAMINATION STATIONS.

Outdoor recreation package, includes 12+ bills, small section with **BOR 75/25 cost** share to conduct inspections and decontamination of vessels operating in Reclamation projects,

(4) LIMITATION.—The Secretaries shall not prohibit access to Federal land and water for vessels under this subsection in the absence of an inspector.

#### Was changed to

 Limitation.--The Secretaries shall not prohibit access to vessels due solely to the absence of a Federal, State, or partner's inspection program or station.

4/9/24 Passed House. Bi partisan Support Agreed to by voice vote.

(3) by adding at the end the following:

### H.R.7659 - Coast Guard Authorization Act of 2024 (Graves (R-

MO), Larsen (D-WA); Webster (R-FL), Rescom (R- PR), Carbajal (D- CA) (3/20/24)

### "SEC. 904. Information on type approval certificates.

"The Commandant of the Coast Guard shall, upon request by any State, the District of Columbia, or any territory of the United States, provide all data possessed by the Coast Guard pertaining to challenge water quality characteristics, challenge water biological organism concentrations, posttreatment water quality characteristics, and post-treatment biological organism concentrations data for a ballast water management system with a type approval certificate approved by the Coast Guard pursuant to subpart 162.060 of title 46, Code of Federal Regulations.".

**Status:** Passed House 5/14/24; Awaiting Senate Action, good chance of becoming law.

= H.R.1452 - To amend the Frank LoBiondo Coast Guard Authorization Act of 2018 to direct the Commandant of the Coast Guard to provide certain data related to water quality, and for other purposes. (3/8/23), Garamendi (D-CA)

## H.R.2881 — Hawaii Invasive Species Protection Act (Case D, Ed [Rep.-D-HI-1]) (Introduced 04/26/2023)

Requires preclearance quarantine inspections for all movement to or from the State of Hawaii by either domestic or international travel, and for other purposes.

Action: House - 06/01/2023 Referred to the Subcommittee on Conservation, Research, and Biotechnology. (<u>All Actions</u>)

NOTE: Hawaii is set to become the sixth state member state of the PSMFC in 2024

- **HB2478/ SB 3167**Authorizes the Governor to execute a compact on behalf of the State to cooperate in the Pacific States Marine Fisheries Commission. Establishes procedures for selection and succession of commissioners
- Action: Passed. 5/2/24 Transmitted to Governor ...99.1% chance of becoming law



## **FY 2024 APPROPRIATIONS**

### Green Crab: Winner, NOAA BIA USFWS, USGS

- Annette Islands Reserve, AK, Metlakatla Indian Community, \$1,000,000 to monitor, survey, and trap European green crab (NOAA)
- \$2,000,000 within Habitat Conservation and Restoration for management, intervention, and mitigation of invasive European green crab (NOAA) ?????yes?
- The Committee provides \$300,000 for European green crab eradication efforts at affected National Wildlife Refuges (USFWS) ??????maybe?
- The Committee encourages BIA to continue to support the work done in fiscal year 2023 to address the problem of the **European green crab** which impacts marine resources for Tribal communities in the Northwest (BIA).
- Biological Threats and Invasive Species Research Program.-The agreement provides \$44,500,000, including funding for research on European Green Crab, Coral Disease, phytoplankton changes in the Great Lakes, and Chronic Wasting Disease at the fiscal year 2023 enacted level. (USGS)

**Frank LoBiondo Coast Guard Authorization Act of 2018 (Public Law 115– 282) :** (f) COASTAL AQUATIC INVASIVE SPECIES MITIGATION GRANT PROGRAM AND MITIGATION FUND.—**Authorized \$ 5 million but never appropriated** 

(i) IN GENERAL.—A grant awarded under the Program shall be used for an activity to carry out thepurposes of the Program, including an activity(I) to develop and implement procedures and programs, including permissible State ballast water inspection programs, to prevent, detect, control, mitigate, and rapidly or progressively eradicate aquatic invasive species in the coastal zone or the EEZ particularly in areas with high numbers of established AIS

(II) to restore habitat impacted by an AIS

(III) to develop new shipboard and land-based ballast water treatment system technologies and performance standards to prevent the introduction of aquatic invasive species;

(IV) to develop mitigation measures to protect natural and cultural living resources, including shellfish, from the impacts of aquatic invasive species; or

(V) to develop mitigation measures to protect infrastructure, such as hydroelectric infrastructure, from aquatic invasive species.

### **Aquatic Invasive Species Commission**

### **Purpose and Objective: Convening to Identify More Effective Solutions**

Leading scientists, conservationists, anglers, boaters, business leaders, and policy experts have convened to assess the persistent threat of AIS and identify more effective solutions. The AIS Commission will invite input from and dialogue with key stakeholders, Federal and State decision makers, Tribal representatives, and other leading experts. The purpose of this collaborative process is to assess the current threat from AIS and gaps in public policy and funding to develop recommendations for how AIS can be addressed more effectively at the Federal, State, Tribal, and regional levels.

## **Aquatic Invasive Species Commission**

### Vision and Key Principles

- Federal policies to address AIS should be clear, cross-cutting, and comprehensive.
- Federal funding to address AIS should be strategic and targeted, providing States, Tribes and Federal agencies with effective tools to combat AIS at a regional and watershed level.
- Laws, regulations, and policies that address AIS should maintain access to responsible boaters, anglers, and other users of our waterways.
- Interstate and regional collaboration, communication and planning is critical to slowing the spread and mitigating the impacts of AIS.
- The recruitment and education of recreational anglers to target invasive species should be prioritized in State and Federal plans and funding opportunities.

#### Section 4: Use of Grant Awards Under Coastal Aquatic Invasive Species Mitigation Grant Program

This section amends the Coast Guard Authorization Act of 2018 to encourage the installation, use, and maintenance of ballast water management systems conforming to, or exceeding, international maritime standards.

#### Section 5: Use of Grant Awards Under Coastal Aquatic Invasive Species Mitigation Grant Program

This section amends the Coast Guard Authorization Act of 2018 [VIDA] to encourage the installation, use, and maintenance of ballast water management systems conforming to, or exceeding, international maritime standards.

# Aquatic Nuisance Species Program Enhancement Act of 2024 (Draft) (AIS 2.0)

## **Section 6: Office of Invasive Species of National Oceanic and Atmospheric Administration**

This section establishes the Office of Invasive Species at NOAA and provides further direction and guidance. The section directs the office to develop a strategy to improve aquatic invasive species management, coordinate with the Coast Guard and EPA to uphold ballast water standards, and represent NOAA on the ANS Task Force. The section authorizes appropriations of \$5,000,000 for the Office of Invasive Species.

**S.773// H.R.1560** — Public Water Supply Invasive Species Compliance Act (Cruz (R-TX) (03/09/23) - exempts certain interstate water transfers from prohibitions on the illegal trade of wildlife, fish, or plants. Re-introduced

S.771// H.R.1558 — Saving America's Vulnerable and Endangered Species Act or the (SAVES) Act. (Cruz R-TX, 03/09/23) This bill prohibits a living nonnative species from being listed as a threatened or endangered species under the Endangered Species Act of 1973. Re-introduced

**S.1614 - Lacey Act Amendments of 2023** (Sen. Marco Rubio (R-FL, 5/16/23)

The legislation "would correct the negative impacts of a 2017 D.C. Circuit Court of Appeals decision that diminished the ability of the U.S. Fish and Wildlife Service to manage the establishment and spread of invasive species in the United States. The bill would also grant authority for emergency designation of species that pose an imminent threat and provide authority to prohibit importation of wildlife species until they have been assessed for injuriousness. The Commerce Clause of the U.S. Constitution charges Congress with regulating commerce between the states and with foreign nations. "

### WRDA CoaSt Guard Authorization APPROPRIATIONS

Impacts to fishes and EFH may occur from noise generated by project vessels and potential introduction of invasive species from non-local project vessels. These potential effects are not expected to affect viability of regional populations or cause long-lasting damage to habitats.
